3. CONDITION UNDER THE WATER ACT:

3.1 The quantity of total water consumption shall not exceed 6.00 KL/Day as per below break up as mentioned in form D submitted for consent application under the Water Act- 1974.

- a) Industrial: 0.00 KL/Day
- b) Domestic: 1.00 KL/Day
- c) Gardening : 5 KL/Day

2. Source of water: SIDC

3.3 The quantity of total waste water generation shall not exceed 0.80 KL / Day as per below break up as mentioned in form D submitted for consent application under the Water Act- 1974.

- a) Industrial: 0.00 KL/Day
- b) Domestic: 0.80 KL/Day

3.4 Industrial effluent management:

- a) Mode of disposal of treated industrial effluent NA
- b) Description for treated industrial effluent disposal NA

3.5 Domestic sewage management:

- a) Mode of disposal of treated domestic sewage Soak Pit/Septic tank
- b) Description for treated domestic sewage disposal: **Generated Sewage shall be disposed off through septic tank/soak pit.**

3.6 There shall be no generation of the industrial effluent from the manufacturing process and other ancillary industrial operations.

3.7 Industry shall affix of water meters for the purpose of measuring and recording the quantity of water consumed at such places as may be required and it shall be presumed that the quantity indicated by the meter has been consumed by the Industry until the contrary is proved.

3.8 The Board reserves the right to review and/or revoke the consent and / or make modifications in the conditions which it seems fit in accordance with provisions of Water Act-1974.

4. CONDITIONS UNDER THE AIR ACT:

4.1 There shall be no use of any fuel anywhere in the manufacturing process and consequently there shall be no flue gas emission from the manufacturing process and any other ancillary industrial operation.

4.2 There shall be no process gas emission from the manufacturing process and any other ancillary industrial operation through various stacks/ vent of reactors, process, vessel from plant premises.

4.3 The concentration of the following parameters in the ambient air within the premises of the unit shall not exceed the limits specified hereunder

1	Particulate Matter (PM10)	60	100
2	Particulate Matter (PM2.5)	40	60
3	Sulphur Dioxide (SO2)	50	80

a. Annual arithmetic mean of minimum 104 measurements in a year at a particular site taken twice a week 24 hourly at uniform intervals.

b. 24 hourly or 08 hourly or 01 hourly monitored values, as applicable, shall be complied with 98% of the time in a year. 2% of the time, they may exceed the limits but not on two consecutive days of monitoring.

4.4 Industry shall take adequate measures for control of noise levels from its own sources within the premises so as to maintain ambient air quality standards in respect of noise to less than 75 dB(a) during day time and 70 dB (A) during night time. Daytime is reckoned in between 6a.m. and 10 p.m. and nighttime is reckoned between 10 p.m. and 6 a.m.

5. AUTHORISATION FOR THE MANAGEMENT & HANDLING OF HAZARDOUS WASTES Form-2 (See rule 6(2))

5.3 The authorization is granted to operate a facility for collection, storage within factory premises, transportation and ultimate disposal of Hazardous wastes as mentioned above.

5.4 The authorization shall be in force for a period as mentioned above.

5.5 The authorization is subject to the conditions stated below and such other conditions as may be specified in the rules from time to time under the Environment (Protection) Act-1986.

5.6 Terms and conditions of authorization:

a. The authorised person shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.

b. The authorisation or its renewal shall be produced for inspection at the request of an

officer authorised by the Gujarat Pollution Control Board

- c. The person authorised shall not rent, lend, sell, transfer or otherwise transport the hazardous and other wastes except what is permitted through this authorisation.
 - d. Any unauthorised change in personnel, equipment or working conditions as mentioned in the application by the person authorised shall constitute a breach of his authorisation.
 - e. The person authorised shall implement Emergency Response Procedure (ERP) for which this authorisation is being granted considering all site specific possible scenarios such as spillages, leakages, fire etc. and their possible impacts and also carry out mock drill in this regard at regular interval of time;
 - f. The person authorised shall comply with the provisions outlined in the Central Pollution Control Board guidelines on "Implementing Liabilities for Environmental Damages due to Handling and Disposal of Hazardous Waste and Penalty"
 - g. It is the duty of the authorised person to take prior permission of the Gujarat Pollution Control Board to close down the facility.
 - h. The imported hazardous and other wastes shall be fully insured for transit as well as for any accidental occurrence and its clean-up operation
 - i. The record of consumption and fate of the imported hazardous and other wastes shall be maintained.
 - j. The hazardous and other waste which gets generated during recycling or reuse or recovery or pre-processing or utilisation of imported hazardous or other wastes shall be treated and disposed of as per specific conditions of authorisation.
 - k. The importer or exporter shall bear the cost of import or export and mitigation of damages if any.
 - l. An application for the renewal of an authorisation shall be made as laid down under these Rules.
 - m. Any other conditions for compliance as per the Guidelines issued by the Ministry of Environment, Forest and Climate Change or Central Pollution Control Board from time to time.
 - n. Annual return (Form - 4) shall be filed by June 30th for the period ensuring 31st March of the year.
- 5.7 The industry shall have to manage used or spent oil; empty or discarded barrels / containers / liners contaminated with hazardous chemicals wastes, process waste as per Hazardous & Other Wastes (Management and Transboundary Movement) Rules-2016, framed under the E(P)Act-1986 and shall apply Authorization for all applicable waste.
- 5.8 The waste generator shall be totally responsible for (i.e. collection, storage, transportation and ultimate disposal) of the wastes generated.
- 5.9 In case of any accident, details of the same shall be submitted in Form - 11 to Gujarat Pollution Control Board.

partners/ directors/ proprietor should immediately be intimate to the Board. Also any change in equipment or working conditions as mentioned in the consent form/ order should immediately be intimated to this Board.

6.2 The industry shall put up at the entrance a board displaying the name of the Industry , particulars of the products/ process and the name of proprietor/partners /directors of the Industry and the electricity consumer number as on the record of DGVCL.

6.3 The environmental statements pertaining to the previous year shall be submitting to this State Board latest by 30th September every year.

6.4 The industry shall carried out adequate plantation all along the periphery of the industrial premises.

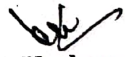
6.5 The industry shall have to display the relevant information with regard to hazardous waste, waste water & air pollutants as indicated in the Courts Order in W.P. No.657 of 1995 dated 14th October-2003.

6.6 As per "Public Liability Insurance Act - 1991", industry shall get Insurance Policy, if applicable.

6.7 The industry shall however, not without the prior consent of the Board bring into use any new or altered outlet for the discharge of effluent or gaseous emission or sewage waste from the proposed Industrial plant.

6.8 The industry is required to comply with the manufacturing, Storage and Import of Hazardous Chemicals Rules-1989 framed under the Environment (Protection) Act-1986.

Without prejudice to the powers of this Board under the Water (Prevention and Control of Pollution) Act-1974, the Air (Prevention and Control of Pollution) Act-1981 and the Environment (Protection) Act-1986 and without reducing your responsibilities under the said Acts in any way, this is to inform you that this Board grants CCA-Ammendment for setting up of an industrial plant/activities at PLOT NO:E-34, E-34, PLOT NO. E-34 VILAYAT GIDC VAGRA DIST. BHARUCH, Vilayat - 392012 DIST: Bharuch, TAL: Vagra, for the manufacturing of the items/products as mentioned in the detailed order WH-85375.

The Validity period of the order is upto 10/10/2028.

1. Order No: WH-85375 & Valid upto :10/10/2028

2. GENERAL CONDITIONS :-

- This order is provisional order and detailed order is considered as final.
- All the conditions and provisions under the Water Act 1974, the Air Act 1981 and the Environment (Protection) Act - 1986 and the rules made there under shall be complied with*.
- All the conditions and provisions under the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 as amended shall be complied with*.
- The concentration of Noise in ambient air within the premises of industrial unit shall not exceed following levels:

Between 6 A.M. and 10 P.M.: 75 dB (A)



Between 10 P.M. and 6 A.M.: 70 dB (A)

- e) In case of change of ownership/management the name and address of the new owners / partners/ directors/ proprietor or equipment or working conditions as mentioned in the consents form/ order should immediately be intimated to the Board.
- f) Industry shall have to display data outside the main factory gate with regard to quantity and nature of hazardous chemicals being handled in the plant, including wastewater and air emissions and hazardous wastes generated within the factory premises.
- g) Adequate plantation shall be carried out all along the periphery of the industrial premises in such a way that the density of plantation is atleast 1000 trees per acre of land and a green belt of 5 meters width is developed.
- h) The applicant shall have to submit the returns in prescribed form regarding water consumption and shall have to make payment of water cess to the Board under the Water Cess Act- 1977.
- i) The applicant shall obtain membership of common infrastructure for disposal of effluent / Hazardous waste.
- j) The applicant shall however, not without the prior consent of the Board bring into use any new or altered outlet for the discharge of effluent or gaseous emission or sewage waste from the proposed industrial plant. The applicant is required to make applications to this Board for this purpose in the prescribed forms under the provisions of the Water Act-1974, the Air Act-1981 and the Environment (Protection) Act-1986.
- k) If it is established by any competent authority that the damage is caused due to their industrial activities to any person or his property, in that case they are obliged to pay the compensation as determined by the competent authority

The Consent is granted on 04/08/2025 by Gujarat Pollution Control Board.
